To Whom It May Concern at Sturbridge Lakes:

We are proposing the following work at the home of Alison Laux (7 Barclay Lane Voorhees, NJ 08043): **replacement of the front entry door.** This is not an in-kind replacement; requesting to change the exterior color and style of the entry door and sidelites.

Details about the new units are as follows:

1 ProVia Legacy Entry Door. 20-gauge smooth steel entry door with clear glass, a Mountain Berry Red exterior, black hardware, and textured aluminum frame cladding in Mountain Berry Red. 24-gauge smooth steel side-lites on both sides with clear glass and a Mountain Berry Red exterior.

The new units have been measured to fit within the existing openings; there is no need for us to alter the size of the existing openings. During the installation process it is common practice for us to inspect the opening after the existing unit is removed in order to ensure that the area surrounding the units is in good shape. Any rot or damage found during that process will be addressed during the installation. Any and all debris created during installation will be handled by our crew and cleaned up before we leave the property.


